



## INFORMATION ON THE PROCESSING OF PERSONAL DATA

### PURSUANT TO ART. 13 OF REG. EU 2016/679

EU Regulation of 27 April 2016, no. 679 provides for the right to the protection of personal data concerning natural persons. In compliance with this legislation, our company, which intends to process your personal data, wishes to inform you in advance, pursuant to art. 13 of EU Reg. 2016/679, that this processing will be based on the principles of lawfulness, fairness and transparency, purpose limitation, data minimisation, accuracy, limitation of retention, integrity and confidentiality and accountability, as well as protection of your privacy and your rights.

#### 1. PURPOSES AND LEGAL BASES OF PROCESSING

Processing is carried out for the following purposes:

- a) being able to contact you again, following your request, to provide information on products/services;
- b) sending you newsletters to subscribe to our mailing list with commercial information, related to the services provided, including promotions, customer satisfaction, news or communications.

Pursuant to Art. 6, paragraph 1, lett.a), it is specified that such processing has its legal basis in the consent of the data subject and that this must be clearly expressed in order for the processing of personal data to be carried out, until the data subject explicitly objects.

Failure to provide your data may result in the impossibility of handling the relevant purposes correctly.

#### 2. PROCESSING MODES

The processing of the data may consist, in addition to their collection, in their registration, storage, modification, communication, deletion and will be carried out both with the use of paper support, and with the aid of electronic tools, according to methods and with instruments suitable to guarantee the security and confidentiality of the data themselves, in accordance with the provisions of EU Reg 2016/679. In particular, all appropriate technical and organisational measures, as provided for in the legislation, will be taken so that an adequate level of data protection is guaranteed. The methods applied ensure that access to the data is only allowed to persons entrusted with the processing by our company.

#### 3. APPOINTEES AND ADDRESSEES

The addressees/appointees to whom your personal data may be communicated are as follows:

- appointees who form part of our company;
- external parties who, on behalf of our company, may carry out management of IT systems and of the website;
- parties to whom the right to access the data is granted by provisions of law or regulations;
- other parties envisaged by law.

#### 4. DATA RETENTION AND TRANSFER PERIOD

The data collected for the purposes referred to in point a) will be duly stored for a maximum period that can be quantified as 5 years from the last contact.

The data collected for the purposes referred to in point b) will be duly stored for a maximum period that can be quantified as 5 years from the last consent.

The Personal Data are stored on servers located within the European Union. It is in any case understood that the Data Controller, should it become necessary to transfer the data to servers also outside the EU, assures as of now that the transfer of the data outside the EU will take place in accordance with the applicable legal provisions, subject to the stipulation of the standard contractual clauses provided for by the European Commission.

**The dissemination of the data is not envisaged** (dissemination = communication to unknown parties).

#### 5. DATA CONTROLLER
